# Approval of Minutes from November 21, 2023 Board Meeting and email votes from November 8, 2023

## **Executive Report Highlights**

**Allen Zeesman** reported on his positive interactions with visitors at Sunday services, would like more participation and focus on hosting/greeting by board members. Jurgen suggests letting people at welcome table that you're there and willing to meet visitors.

**Sara Rutherford** still working to get Breeze up and running, will begin testing payment methods. **Phyllis Vince reported on the November expense and YTD report.** Budget report attached.

# 2024 Budget approval process (Allen Zeesman)

Discussion of the process for finalizing a 20024 budget, in line with recently passed process involving a three-part series of meetings.

There was agreement on the changes needed in this process to conform with need for the first and third meetings to be meetings of the full Memership. Amended process will be presented to Board for an email vote to approve the changes.

Allen Zeesman and Susan MacDonnell will meet in the coming week to develop a timeline and plan for the required Membership and Board meetings to approve a 2024 Budget.

Dan reminded the board that there will be no approved budget for Jan 2024. Need to ask membership to pass a budget continuation, similar to last year.

Dan will send a survey to the membership asking for a vote to APPROVE or REJECT a continuation budget for Quarter 1 of 2024, using the budget for Quarter 1 of 2023.

# Discussion of UUSFSMA Google Group and creation of policy/rules for participation

This conversation regarding establishing firmer rules/expectations follows weeks of negative and inaccurate communications from a small number of members on the GG email. While there has been a dramatic increase in negativity recently, the problem has been ongoing. Since the GoogleGroup is a creation of the UUFSMA as a service to members, Allen and Paula are requesting intervention by the board to address the abuses.

#### Discussion included:

- Chris drew attention to what is the fine print at bottom of the GG screen, outlining rules of use and the behavior expectations.
- Discontinue Google Group entirely, or close it down now and rebuild it at beginning of 2024.
- Do not distribute official UUFSMA communications (board and member notices, etc) through Google Group. These would only come directly to members via email and/or newsletter.
- Have one or more people monitor posts, communicate with Ivan Mendez to ask for removal of specific posts as necessary.
- Pre-approval of posts a 24-hour review process as many GGs use. This would be time and energy consuming, probably not sustainable.
- Paula Peace suggested that monitoring/removal sounds like a Healthy Community Teams task. For reasons of HCT members at this point in time, this would be difficult to sustain.
- Chris add language to the GG rules to direct members to specific contact with the Board if there are issues they want to raise or get clarity on. Board, through President, would commit to responding to all who contact him (and making the reply public somehow?)

Anne Geyer and Paula Peace volunteered to co-write a statement about deactivating the Google Group for a short time, in order to revise rules of engagement.

**Motion** made by Chris Chase: To shut down the UUFSMA Google Group as soon as there is finalized statement written and approved for distribution to members under Allen Zeesman's name as President.

Second by Phyllis Vince, unanimous. (Reversed by email vote, Dec. 30, 2023)

Covenant (Peace)

"We covenant to promote a peaceful world community with liberty and human rights for all. Whenever and wherever possible we will use nonviolent means to achieve peace."
